## INTERNATIONAL TRADE IN SERVICES STATISTICS Annual 2023

Fiji's International Trade in Services Statistics [ITSS] provides information on the value of import and export of services between Fiji and the rest of the world. The information used in this release is from the International Trade in Services Survey and Administrative Sources.

### Export - Services

Increased by \$1,625.0m (55.0%) when compared to Annual 2022.



Increased by \$840.5m (55.1%) due to an increase in personal travel services.

Increased by \$701.0m (65.7%) due to an increase in air transport services.

Increased by \$52.7m (84.2%) due to an increase in technical, trade-related and other business services.

### Imports – Services

Increased by \$401.8m (24.1%) when compared to Annual 2022.



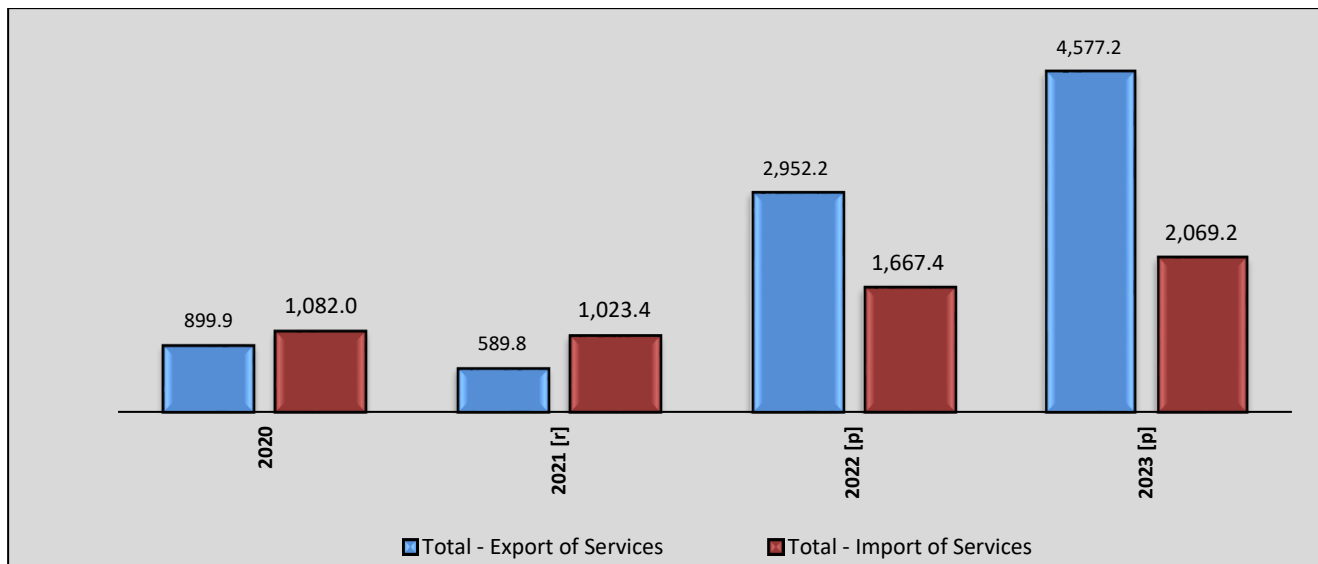
Increased by \$235.4m (66.2%) due to an increase in personal travel services.

Increased by \$116.2m (13.2%) due to an increase in sea freight services.

Increased by \$18.0m (9.9%) due to an increase in technical, trade-related and other business services.

\* The above three categories were major contributors to the change in export and import of services.

Graph 1: Fiji's Overall Performance [FJD-Millions]




